

## Covid safety modifications



As the world adapts to a new normalized version of living with COVID, so has the healthcare industry. To that point, OCB began lifting some, but not all, COVID restrictions that went into effect April 1, 2023. When you come to our offices you'll notice some changes have occurred. ## Artificial tears and eye ointment recall



Amid news reports several weeks ago concerning bacterial contamination of certain brands of eye drops, OCB has received phone calls from concerned patients who want to know if their brand is safe. At this time, Massachusetts is not among the states that have had cases of eye infections due to contaminated drops reported. Manufacturer Global Pharma, based in India, produces Delsam Pharma and EzriCare products and has initiated a voluntary recall. It has been reported in news outlets that the products in

question were purchased online before the recall. Several batches of another brand of drops, Purely Soothing, were also voluntarily recalled by manufacturer Pharmedica USA, due to concerns over contamination. However, no eye infections have been reported due to use of this brand of drops. Consumers with questions concerning the Purely Soothing 15% MSM recall can contact Pharmedica at osm@pharmedicausa.com or by calling (623) 698-1752. If you are using any of the following products, discontinue using them.

- -EzriCare Artificial Tears
- -Delsam Pharma Artificial Tears
- -Delsam Pharma Eye Ointment
- -Purely Soothing 15% MSM

All other brands of artificial tears and eye ointments are safe to use. Patients who have signs or symptoms of an eye infection should talk to their eye doctor or seek immediate medical care.
